## Prerequisites and eligibility

### Entry requirements:

- Completed an undergraduate degree\* in a cognate discipline, or equivalent; and at least two years of full-time, documented work experience;  
OR
- A minimum of eight years of full-time documented, relevant work experience;  
PLUS
- Evidence of completion of prior narrative therapy studies at Dulwich Centre ([Level One Intensive](#)) or equivalent;
- Completion of the [personal statement document](#) (maximum 500 words);
- A [professional referee report](#)

\*There is an entry pathway for Aboriginal and/or Torres Strait Islander applicants without an undergraduate degree. If this is the case for you, please [write to us](#). 42 Indigenous Australians have already graduated from this Master's program. Some have not had undergraduate degrees ... and some of these participants have graduated with First Class Honours.

### Work experience:

- *I don't work as a counsellor, can I still do the Masters?*

Yes! The Masters is not just for counsellors or people working in traditional one-on-one counselling roles. As long as you meet the entry requirements and have a context to put narrative ideas into practice for a minimum of five hours per week throughout the year, you are welcome to join the Masters.

### Narrative therapy training:

- *How much narrative therapy training do I need to have completed to be eligible?*

Participants need to have completed a minimum of a thirty-hour Level One Intensive in narrative therapy, or the equivalent hours of introductory narrative therapy training. If your training was completed more than five years ago, please [email us](#).

As the Masters specifically focusses on narrative therapy and community work, training in other therapeutic approaches won't count towards this prerequisite.

- *How do I find out if alternative narrative therapy training I've completed is adequate for the Masters?*

Please send us an email with an overview of the training you have completed. The details to include are: the duration (hours) of the training, teacher(s), what topics were covered, and a course handbook or syllabus (in English). If you haven't done the equivalent of a five-day Intensive, we will explore possible ways for you to do so (wherever you may be located).

- ***I've completed a long-term narrative therapy study program. How do I find out if I'm eligible for recognition of prior learning?***

Please send an [email to us](#) and include:

- An outline of the course that you have studied, with a particular emphasis on the number of hours and the content that was dedicated to narrative practice skills
- The assessment tasks
- Teaching faculty
- The contact details of the main teacher or facilitator in case we need to reach out

#### Education:

- ***Will my undergraduate degree will be accepted as a cognate discipline or equivalent?***

If you are unsure about this, please [email us](#) with details of your undergraduate degree [transcript, testamur etc] and we will let you know.

- ***I am an Indigenous Australian and I don't have an undergraduate degree. Is it still possible for me to apply?***

Yes. There is a pathway into this Masters for Aboriginal and Torres Strait Islander practitioners who may not have an undergraduate degree. If this is the case for you, please [write to us](#). 42 Indigenous Australians have already graduated from this Master's program. Some have not had undergraduate degrees ... and some of these participants have graduated with First Class Honours (click here to watch [their valedictory speech](#)).

#### English language requirements (non-English speaking background):

- ***How can I demonstrate my English proficiency if I did not complete an undergraduate degree in English?***

## Applying

- ***How do I apply?***

Applications for 2027 Start Year Intake (February) will open in August: <https://study.unimelb.edu.au/find/courses/graduate/master-of-narrative-therapy-and-community-work/how-to-apply/>. The deadline for applications will be in January 2027\* (date tbc), however we really recommend sending your application well before then. Applications are reviewed on a rolling basis, so the sooner you submit your application, the sooner you will be advised of the outcome.

If you encounter any difficulties whilst completing your application, please reach out to the [Continuing Education team](#) at the University of Melbourne and they will be able to assist.

\*Anyone applying for the [Anita Morawetz scholarship](#) must submit their full application by November 2026 (date tbc).

- ***What do I need to prepare for my application?***

You will need to have the following documents to apply:

- Transcripts and diplomas/certificates of previously completed study. Transcripts should also include an explanation of the grading system used.
- An up-to-date CV outlining your current and previous roles, and the number of months/years you spent in the role.
- Evidence of completion of prior narrative therapy studies.
- Evidence of meeting the English language requirements (for people from a non-English speaking background, see [here](#) for more info).
- A 500-word personal statement completed on the template found [here](#).
- A professional referee report, completed on the template found [here](#) by your chosen referee/s.

- ***What should I include in my 500-word statement?***

You will need to complete the personal statement template, which you can download [here](#). This template outlines what you should write about, including: why you want to complete the Masters, what context you'll put the ideas into practice, and any ideas you have about the research innovation project completed in Subject 3, Narrative Practice and Research Synthesis.

- ***Is there a standard format for the professional referee report? Is there a limit to how many I should include?***

The professional referee report will need to be completed on the template available [here](#) by your chosen referee. Your referee should be somebody who you currently work with and who can vouch for you on a professional level. You can submit more than one reference from separate referees.

## Key dates

- ***What are the subject dates?***

*Please note, these dates are to be confirmed for 2027:*

- Subject 1 (Advanced Narrative Skills Development): 8<sup>th</sup> February – 9<sup>th</sup> July 2027 (TBC)
- Subject 2 (The Art of Narrative Practice): 19<sup>th</sup> July – 12<sup>th</sup> November 2027 (TBC)
- Subject 3 (Narrative Practice and Research Synthesis): 8<sup>th</sup> February – 26<sup>th</sup> November 2027 (TBC)

- ***What are the dates for the online teaching blocks?***

The tentative dates for the online teaching blocks are below. Depending on whether you are enrolled as a part-time or full-time student, you may attend some or all the blocks. You can read more about attending the online teaching blocks in the following questions.

## Online learning and teaching blocks

- ***Will the program be online only in 2027? Will there be any face-to-face opportunities?***

The 2027 program will be entirely online. This makes the course accessible to everybody, including those who are interested but can't come to Adelaide for the teaching blocks.

In 2027 there will be a face-to-face event for Masters alumni from all years, held in Tarntanya Adelaide in the first half of the year. This event will also be open to participants of the 2027 Masters! This is optional and not a formal part of studies.

- ***Do we have to attend the entire teaching blocks live, even if our time zone is quite different than Adelaide's?***

We understand many participants' time zones are quite different from Australia's, and we do our best to accommodate this. For the Masters teaching blocks, we offer sessions at a variety of time zones. Participants are expected to attend as many of the sessions as is accessible for their time zone and review the recordings if they miss sessions.

The teaching blocks include interactive live sessions held on Zoom, as well as offline activities and exercises to do in your own context with a practice partner. It's important to attend as much of the training as possible live, as it is designed to be interactive and collaborative. You may need to arrange study leave from work for the duration of the teaching blocks. We can supply a letter for your employer/manager, outlining the importance of you attending this training live.

### **Study modes and time commitment**

- ***What are the options for part-time study?***

The Masters can be completed part-time over two years. As a part-time participant, you complete Subject 1 and 2 in the first year, and Subject 3 in the second year.

- ***How much time should I expect to put aside each week for the course?***

As this is an online Masters, there is some flexibility with how much time you spend studying each week. Events such as the online teaching blocks and Meet the Author sessions require live attendance. Outside of these events, you can decide what amount of time works best for you to study each week. As this is a practice-based course, a lot of work is put into ensuring participants can rigorously engage with the ideas. The course handbook (available in late 2026) will outline the assignment dates and give you a better sense of what's possible for you.

The time spent on the course will vary significantly based on participants' individual learning styles. As a rough estimate, the total course will require approximately 1020 hours of student work, including the five hours per week of putting ideas into practice. This total doesn't include the hours spent in the online teaching blocks. If you study full-time, this works out at approximately two days of study per week over the year (plus five hours of putting the ideas into practice). If you study part-time, this works out to one day of study per week over the two years (plus five hours of putting the ideas into practice).

- ***What counts as five hours of practice per week?***

The Masters is a practice-based program, and it's important that you are putting narrative ideas into practice **at least** five hours per week (on average), or 180 hours per year, for the duration of the program. This can occur in many different contexts – paid or unpaid. It can be in one-on-one counselling work, or with families, groups or communities. It can happen face-to-face or online (via Zoom).

It's important that in these hours you are using narrative practices in direct work with people. Teaching *about* narrative practice does not count. If you have any questions or concerns about your context, please get in touch. Due to the emphasis on practice within the course, you need to have adequate practice opportunities arranged **prior** to starting the Masters.

- ***I noticed that there are no clinical hours or supervision mentioned. Does the program include this?***

Whilst participants are required to log five hours of practice per week, there is no official placement or supervision of clinical hours as part of the program.

## Fees and scholarships

- ***Is the course is covered by FEE-HELP?***

Yes, the course is covered by FEE-HELP. If you are eligible for FEE-HELP, you can opt into it during the application stage. For more information on FEE-HELP, see the [Study Assist website](#).

- ***Are there Commonwealth Supported Places (CSP) available for this program?***

No, there are not Commonwealth Supported Places available for this program.

- ***Is the fee the same for international students?***

Yes, the fee is the same for international students. Please note that this course is not available to international students who require a student visa to study in Australia, as it does not meet the onshore study requirements.

- ***Is there a fee difference between full-time and part-time students for the Master program?***

There is no difference in fees, regardless of whether you study part-time or full-time. Subject prices may increase from one calendar year to the next.

- ***Can I have a breakdown of the cost per subject?***

The cost of each subject is below ... the prices for 2026\* are:

- Advanced Narrative Skills Development: AUD\$7,000
- The Art of Narrative Practice: AUD\$7,000
- Narrative Practice and Research Synthesis: AUD\$14,000

- ***What scholarships are available for this degree?***

- ***Can international students apply for the Anita Morawetz Scholarship?***

Yes, this scholarship is open to international applicants. The scholarship is open for award to students whose project within the Master's program will 'contribute to the clinical practice of family therapy in Australia'. The work does not have to take place within Australia.

## Accreditation and professional recognition

- ***If I complete the Masters will it be recognised in my country?***

The Master of Narrative Therapy and Community Work is a postgraduate degree offered by the University of Melbourne in collaboration with Dulwich Centre. The program adheres to internationally accepted AQF standards. The University of Melbourne is ranked the #1 Australian University and #19 in the world (QS World University Rankings 2026).

In terms of the program being recognised for registration with professional organisations in your country, please check directly with the organisation you are seeking recognition from. Requirements for this vary significantly across countries and organisations.

- ***Will completing the Masters entitle me to membership in the Australian Association of Social Workers (AASW) or the Australian Psychological Society (APS)?***

The Masters is accredited by the Australian Counselling Association (ACA). For more information about this, we recommend you contact the [ACA directly](#). The Masters is not accredited by the AASW or the APS, and won't entitle you to membership with either association.
